I am writing in request for a kennel license. I am a guide and breeder; I work for a hunt club in Capac Mi (Pheasant Ridge) and guide in South Dakota and Iowa. I have four Labrador retrievers ranging in ages, 11, 7.5, 5.5 and 2.5, they are AKC registered, micro chipped, OFA certified (hips), OFEL certified (elbows), CERF (canine eye registration foundation) EIC (exercise induced collapse and recovery), and DNA. The 11 is a retired dog and stays mainly in the house, I am a registered breeder with the AKC, and sell pups for companions and hunt dogs on occasion I am asked to start the pups on basic commands before they are delivered. I use a two and two system, two dogs work while two dogs rest. It takes approximately 2 to 3 years to produce a finished dog, and I need to introduce a pup into training to maintain a two and two system. I have a 150 ft x 55ft back yard; I am presently getting quotes to erect a stockade privacy fence to be constructed around the back yard. I use a 10 x 12 shed as a kennel and am getting quotes for cement to come off the kennel with separate runs. Terry Sharp outdoor writer for the Free press and Detroit news has written articles about how I train my dogs in down town Detroit, and last year a short film for Michigan outdoors that never aired (hand held camera bad filming). I would appreciate your approval for a kennel license as my reputation is getting larger in the hunting community. Thank you

### NOTICE TO OWNERS & RESIDENTS

This notice has been sent to you in compliance with Section 75-14B of the Code of Ordinances for the City of Roseville.

City Council has received an appeal of the denial of a kennel license from applicant James Heck, Ordinance requires a kennel license to be obtained if more than 3 dogs are habitually kept or harbored on the premises. Mr. Heck wishes to harbor a number of dogs exceeding those allowed by ordinance. Mr. Heck raises champion hunting dogs. His breeding dogs usually have two litters a year, which he raises, trains, and sells. Upon denial of the license by the Police Chief, the applicant has requested an appeal to the City Council.

City Council will consider this matter at their next regular meeting to be held Tuesday, May 27, 2014 at 7 p.m. in the Council Chambers. Your comments are invited either in person at the first Hearing of the Public for Agenda Items, or by letter addressed to the City Manager, 29777 Gratiot Avenue, Roseville 48066.
