**TRAFFIC CONTROL ORDER**  
**CITY OF ROSEVILLE**

**WHEREAS**, under the provisions of Section 340-19, Sub – Section 257.71 of Ordinance 895 of the Code of Ordinances of the City of Roseville, Michigan, as amended, the City of Roseville Police Department Traffic Bureau is authorized to place and maintain traffic control devices and traffic control signals on any public highway, street, alley or roadway under its jurisdiction, for the purpose of regulation, warning or guiding traffic; and

**WHEREAS**,

Is/are road(s) under the jurisdiction of the City of Roseville Police Department Traffic Bureau, and in the interest of public safety, it is deemed necessary to place and maintain certain control devices and/or signals on said road(s) to regulate, warn of guide traffic.

**NOW, THEREFORE, BE IT RESOLVED THAT**, due to citizen complaints of blatant disregard for the current in place Yield sign on southbound Massachusetts Street at Wilfred Street that said Yield sign be replaced with a Stop sign.

**BE IT FURTHER RESOLVED THAT**, that this change shall be in full effect for ninety days. During this time Officers of the Roseville Police Department Traffic Bureau shall monitor traffic flow and compliance with the new signage. At the conclusion of the ninety day study period unless otherwise requested this order shall become permanent.

**BE IT FURTHER RESOLVED THAT**, a certified copy hereof be filed with the City Clerk of the City of Roseville, Michigan
