NOTICE OF REVISED INTENT TO APPLY FOR FUNDING

TO ALL INTERESTED PERSONS, GROUPS AND AGENCIES: The City of Roseville has made an Environmental Review Record for the above named program. It documents the environmental review of the proposed activities in the Community Development Block Grant (CDBG) Program. The City of Roseville has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR). The Environmental Review Record is on file in the City of Roseville Community & Economic Development Department (586) 445-5423 at the Roseville City Hall, 29777 Gratiot Avenue in Roseville, and may be viewed between 9:00 AM and 3:30 PM, Monday through Friday.

No further environmental review of the project is proposed to be conducted prior to the request for release of federal funds. All parties disagreeing with this decision are invited to submit comments for consideration by the Roseville City Manager. Such comments should be received no later than 4:00 PM on Wednesday, July 12th, 2017. All comments will be considered, and the City will not request release of federal funds or take an administrative action on the named project prior to the date specified in the preceding sentence. On or about August 16, 2017, the City of Roseville will submit a Request for Release of Funds to the United States Department of Housing and Urban Development (HUD) for the release of Community Development Block Grant Funds under Title I of the Housing and Community Development Act of 1974 (93-383), as amended. The grant, under Title I is to be used for the following 2017-2018 projects/activities:

Local Road Resurfacing (\$325,805) – Reconstruction of eligible residential road located in Census Tract 2558, Block Group 3; Sycamore from Gratiot Avenue to Spruce Street.

The City of Roseville certifies to HUD that the City Manager in his official capacity as Certifying Officer consents to accept the jurisdiction of the federal courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD approval of the certification satisfies its responsibilities under NEPA and related laws and authorities, and allows the City of Roseville to use program funds. HUD will accept objections to its Release of Funds and the City of Roseville's certification only if it is on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Roseville; (b) the City of Roseville has omitted a step or failed to make a decision of finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient has committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of Release of Funds by HUD; or (d) another Federal Agency acting pursuant to 40 CFR part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedure (24 CFR Part 58) and shall be addressed as follows:

No objection received after August 16, 2017 will be considered by HUD. Upon approval of the application, the City of Roseville and the Department of Housing and Urban Development will have satisfied the responsibilities under the National Environmental Policy Act of 1969 (NEPA).
