This is Eric Errickson. I am writing on behalf of the Roseville Goodfellows.

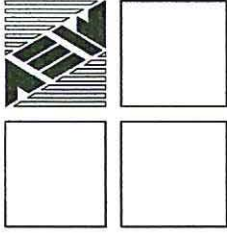

Dear Mr. Adkins:

On Tuesday, June 27, 2017, three (3) bids were received for the project referenced above. Our office has checked the bid tabulation and a copy is attached for your use. The low bidder is Florence Cement Company with a total bid amount of \$544,606.13.

We have worked previously with Florence Cement in Roseville and nearby communities and are satisfied with their performance.

Please note, an alternate for resurfacing instead of concrete reconstruction for a significant portion of the street was also provided. Florence Cement was also the low bidder for the alternate with a total bid amount of \$450,462.88. However, based on the prices submitted and the availability of funds we are recommending an award for the base bid (complete concrete reconstruction).

Based on our experience, availability of funds and bids submitted, we recommend a contract for the **Wilfred and Massachusetts Street Reconstruction Project** be awarded to **Florence Cement Company**, 12585 23 Mile Road, Shelby Twp. MI 48315 in the amount of **\$544,606.13**.

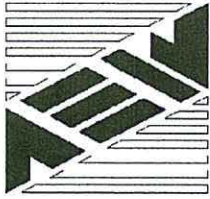
