

## **NOTICE TO ALL BIDDERS**

The City of Roseville will be accepting sealed bids up to **9:00 a.m., November 9, 2015** for the attached properties.

Properties shall be bid as one package and must be accompanied by a 10% deposit in the form of a cashier's check or certified check. **Minimum bid \$250,000.** Purchasers must agree to comply with the following terms:

- a. Must obtain all required permits within 45 days of closing and prior to commencing repairs.
- b. Must replace all plumbing components that are not code compliant or submit a letter from a licensed plumbing contractor stating that all components are in safe proper working order. This must be completed within 6 months from closing.
- c. Must replace all mechanical components that are not code compliant or submit a letter from a licensed mechanical contractor stating that all components are in safe proper working order. This must be completed within 6 months from closing.
- d. Must replace all electrical components that are not code compliant or submit a letter from a licensed electrical contractor stating that all components are in safe proper working order. This must be completed within 6 months from closing.
- e. Must repair or replace all building components that are not code compliant. This must be completed within 6 months from closing.
- f. All sales are as is condition without warranties or representations as to the condition of the properties.
- g. Properties that the purchaser determines are not economically feasible to renovate shall be demolished to specifications of the City of Roseville within 120 days of the date of purchase.
- h. If deemed in the best interest of the City of Roseville, a lower bid offering to market a high percent of homes to owner-occupied individuals may be considered.
- i. Buyer is responsible for winter taxes.

The City of Roseville reserves the rights to accept or reject any and all bids that they determine are not in the best interest of the City.

Bidders may obtain a **KEY** for viewing properties from the Purchasing Department with a \$1,500 deposit in the form of a cashier's or certified check and by signing a Hold Harmless Agreement. The \$1,500 deposit will be deducted from the sale price of the awarded bidder or be refunded upon return of the key.

The Inspector further agrees to pay all costs, including attorney fees for counsel as chosen by the City to defend all claims, actions, causes of action, or any other rights asserted against the City, its agents, servants and employees, arising out of inspecting the various Roseville properties for possible purchase, and further to pay any judgments and/or settlements awarded and/or agreed to in connection therewith. The City shall retain sole authority to settle or compromise any claim.
